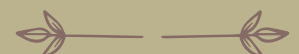

## Preparing for Consistency

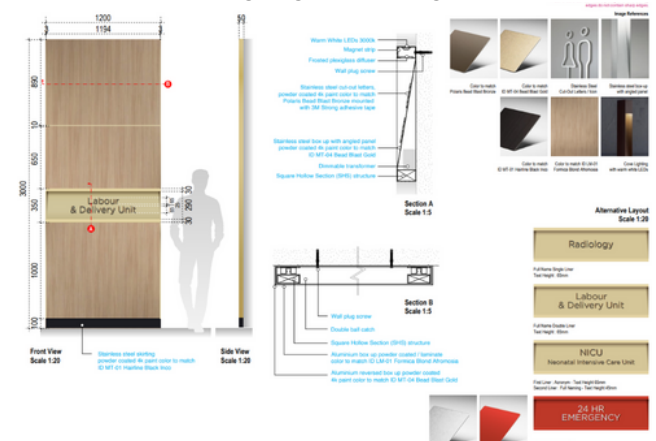
With the right-siting and rationalization of clinical assets, there is a need to rationalize how we name our wards and beds to accommodate the new way-finding and operational flows for patients, visitors, doctors and staff. These will progressively be incorporated into new signages around the hospital and in public areas.

The Intensive Care Unit (ICU) will be the first to adopt the new nomenclature in August 2023.

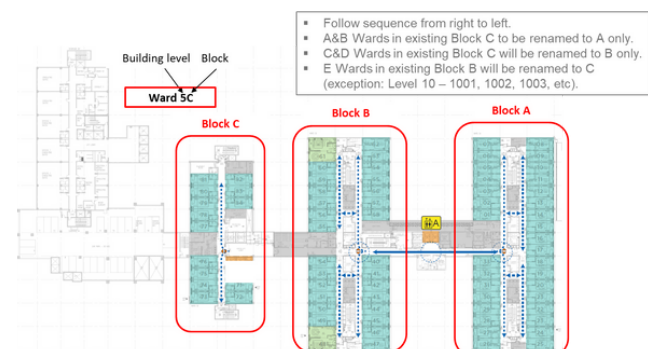
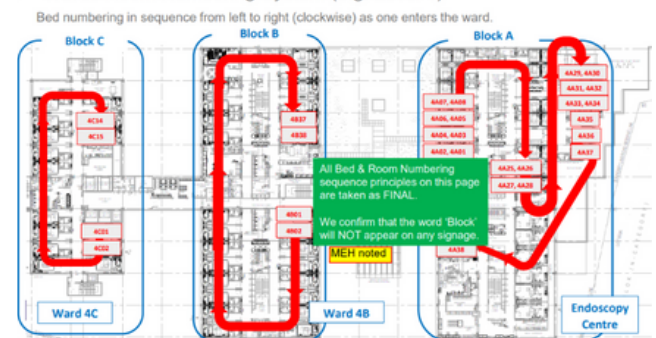


Mock up & Work in Progress

### Wards Room Numbering System (e.g. Level 4)



- Follow sequence from right to left.
- A&B Wards in existing Block C to be renamed to A only.
- C&D Wards in existing Block C will be renamed to B only.
- E Wards in existing Block B will be renamed to C (exception: Level 10 – 1001, 1002, 1003, etc).

# Temporary Areas

## NON-INVASIVE CARDIAC LAB (NICL)



### Temporary relocation of Non-Invasive Cardiac Lab (NICL) Operational from 19 July 2023

NICL services will be distributed across two new locations on Level 5.

NICL Block C Level 5 (formally Victoria Lounge) services:

- Patient Registration and Billing
- Electroencephalography (EEG)
- Lung Function Test

NICL Block B Level 5 (formally Nursing Administration Office) services:

- Transoesophageal Echocardiography (TEE)
- Electrocardiogram (ECG)
- Echocardiogram Stress Test

## ACCIDENT & EMERGENCY



### Temporary relocation of Accident & Emergency Department (A&E) Operational from 19 July 2023

A&E services is now located outside Hospital Main Lobby on Level 2 (formerly Fever Tent).

We are currently working on the permit to air-condition our A&E.



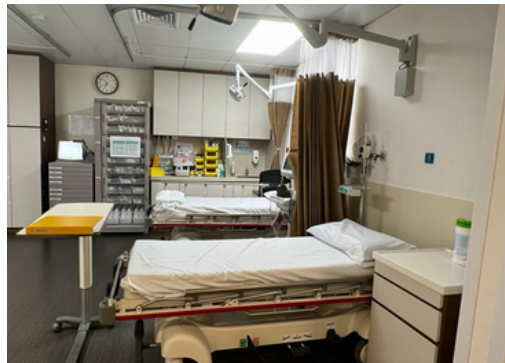
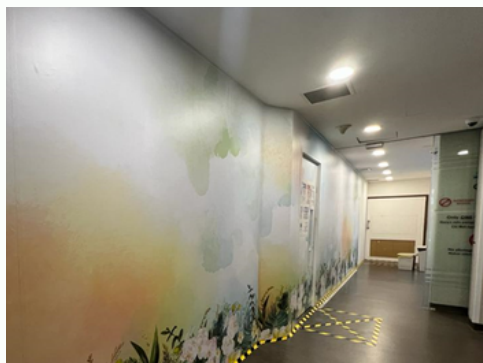

## Construction & Demarcated Lines III



### CLOSURE OF ACCESS AT LEVEL 1

Closure Details:

Effective Date: 7th August 2023

Expected Duration: 17th November 2023

Affected Area: Entire corridor from Level 1 Block B Lift Lobby

Commencing from 7th August 2023 and till 17th November 2023, we will expand the existing hoarding at Level 1 Block B Lift Lobby.

This extension is necessary to facilitate various essential activities, including complex M&E work, service diversions, delivery & installation of new lifts, and fire compliance work for the Protected Lift Lobby.

### Human Traffic Diversion and Operation Flow:

Main corridor in front of the Lift lobby will be inaccessible to human traffic, except in the case of a fire emergency.

### Access to Lifts M & N at Level 1:

There will be no access to Lifts M & N at Level 1 for all individuals entering from Block B Entrance.

### Wheelchair Accessibility:

Lifts M & N at Level 1 will no longer be accessible to wheelchair-assisted patients if they are dropped off at Block B Entrance.

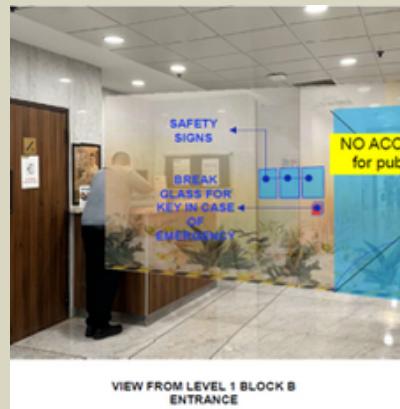
They will be required to use the MEMC lifts, where they can transfer to the Hospital area at Level 2.

### Ambulance Drop-Off:

All ambulance drop-offs should be directed to the Hospital Main Lobby at Level 2 till 17 November 2023.

### Availability of Staircase:

The staircase beside the security office will remain available for use as an alternate means of access.

## BASEMENT BUNKER

### AT CARPARK LEVELS 1A AND 1B

Part of Carpark hoardings under Phase 2 at Level 1A & 1B are removed.

- Completion of New Decay Tanks for Nuclear Medicine
- Testing & Commissioning will be done upon completion of New Hot Lab and New Isotope Room in 2024.
- 12 Carpark lots have been made available as of 25 July 2023

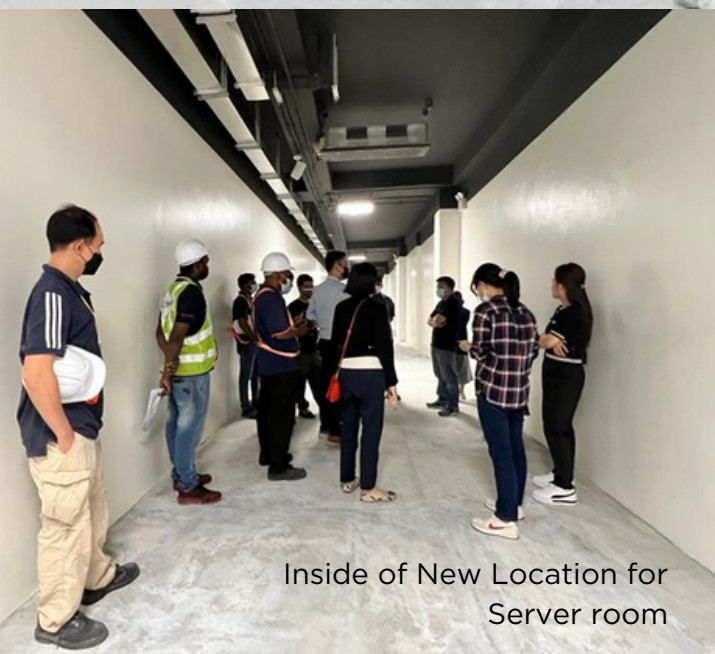
